## Pure Dermatology Membership Consent and Terms

By electing to purchase a Pure Dermatology membership, you agree to be bound to these terms and conditions as a “member” referenced here and throughout.

### **Membership fees:**

Your monthly membership fees will accrue in your Pure Dermatology account as a credit amount towards cosmetic services or product purchases at Pure Dermatology. As a member, you will have access to the benefits specified within your membership at any time during active membership. The accrued amount will go towards these services, after having the applicable discount applied to your treatment total. Any balance remaining on a service or purchase after applying applicable discounts and accrued credit on account will be due at the time of service.

All payments are securely processed and compliant with our financial policy. Pure Dermatology reserves the right to refuse or cancel any transaction for any reason. Pure Dermatology may update or change any services, costs, or terms related to a membership at any time. Changes or updates will be provided to members 30 days prior to going in effect for reasonable consideration time.

Discounts from aesthetic companies and Pure Dermatology radiance bucks cannot be used to pay for membership fees; however, they can be used in conjunction with your membership credits to pay in full for services rendered.

### **Billing/Drafting:**

Memberships will be billed on a subscription basis, as a recurring monthly auto-draft. Enrollment and purchase of a membership requires the member to provide a valid credit card, accurate and complete billing information, and consent to draft signed by the card holder. Following the initial purchase, membership fees will be processed and drafted from member’s accounts the first Monday of each month.

Members are responsible to update Pure Dermatology with any changes to their billing information. Failure to process automatic membership fee payments (i.e. change to credit card number) will result in termination of membership and loss of associated perks and benefits.

### **Cancellation:**

You may cancel your membership at any time with 30 days written notice to [courtney@puredermnola.com](mailto:courtney@puredermnola.com) or [info@puredermnola.com](mailto:info@puredermnola.com) or via mail. Your remaining credit will not be refunded but will remain as a credit following the “termination” section below. Receipt of a cancellation request will warrant effective the first processing month following a 30-day advance cancellation request.

### **Termination:**

Pure Dermatology will terminate your membership if there is no activity in the practice for 6 months. A notice will be sent to the member indicating the effective termination. At this time, you will be able to spend the accrued funds on your account at Pure Dermatology without applicable membership discounts applied. Funds that remain unused for 6 months following the ‘inactivity 6-month termination period’ will result in forfeiture of funds (Total 1.5 years of inactivity).

### **Refunds:**

All payments made are non-refundable and non-transferrable. Unused funds remaining on an account will hold value for use within the practice. No cash refunds are issued.



**Services:**

Members are allowed access to schedule any appointment necessary, at any time, as they normally would, regardless of relation to membership. Discounts offered for each membership type will be applied automatically to all services applicable to your membership at the time of use.

While monthly fees are due, we understand that monthly treatment may or may not be necessary for you. Pure Dermatology’s memberships are created with the goal of providing patients a reasonable, cost-effective option to remain regular, compliant, and able to follow through on full-corrective treatment. Please refer to the recommendation of your individual treatment plan provided by your physician to determine frequency of treatment. A month spent without services rendered cause no loss of fees, rather accrues as a credit in your account for future use.

It is the responsibility of the patient to initiate scheduling for an appointment to render services.

**Missed Appointments:**

In accordance with our Missed Appointment Policy, scheduled appointments require 24-hour notice cancellation or incur a \$100 fee on the account. Any balances incurred on a patient’s account for missed appointments, will apply membership fees to maintain a clear statement of account and proceed with future booking.
